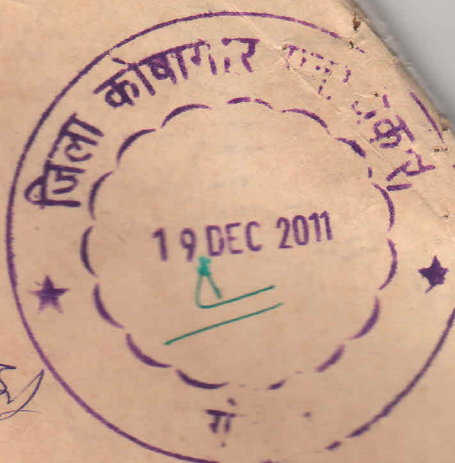

Objects :- The aims and objects of the trust shall be -

To develop the education, Socio economic sector training social welfare of humanity and other allied incidental activities in all its aspects on modern scientific lines with a view to propagate the knowledge and technique of this subjects among linguistic minority groups and weaker sections of society there by enabling them to effectively participate in the national development.
- b. To educate all section of society
- c. To promote comparative studies among linguistics
- d. To run educational institutions such as schools, colleges, Polytechnics, technical institute, technological study circles, medical colleges, hospitals, clinics recreation centers, training cum production centers social welfare centers, family welfare centers orphanages, adult education management and Para medical courses, fine arts, law aster degree courses in science, arts and commerce faculty and hostels for boys and girls and working women's hostel in urban and rural areas.

 - v. To borrow take loan from banks, financial institutions borrow or raise any money that may be required by the trust for the achievement of its object upon such terms as may be deemed advisable and in particular by the issue of promissory notes or by mortgage or charge on all or any part of the immovable or movable assets belonging to the trust.



- IX. Accounts - The trustees shall duly maintain true and correct accounts of all assets, liabilities, receipts and expense of the trust and a correct record of the meetings and deliberations. The year of account of the trust shall be the 1st of April to the 31st Of March every year. It shall however be opened to the trustees to change the year of account if they find it more convenient to do so.
- X. Indemnity - The trustees shall be indemnified against any action or proceedings, cost or claim, demand or liability for anything done by them in good faith, pursuant to the power and authority vested in them under this deed.
- XI. Amendments to the trust deed :- No amendments to this trust deed or any rules or regulations framed by the trustees, shall be made which may prove to be repugnant to the provisions of section 2 (15), 11- 13 and 80 G of the income tax act 1961. Subject to the above, the trustees may amend the provisions of the trust deed, provided however no amendment shall be carried out without the prior approval of the commissioner of income tax.
- XII. Irrevocable :- The trust formed shall be irrevocable.
- XIII. Dissolution of the trust :- In the event of dissolution or winding up of the trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the trustees but the same shall be transferred to another charitable trust, society, association, or institute whose objects are similar to those of this trust and which enjoys recognition under section 80 of Income Tax Act 1961.
- XIV. Utilization of the funds and income of the trust :- The funds and income of the trust shall be utilized for the achievement of the objects of the trust and no portion of it shall be utilized for payment to the trustees by the way of profit interest or dividend the trustees who render fulfill professional or other services to the trust shall be paid a honorarium amount monthly.
- XV. Audit : The board of trustees shall get the accounts of the trust duly audited every year by a Chartered Accountant.
- XVI. Working Area:- Jharkhand.
